Cary A. Aspy, 49, of Decatur, died on Monday, October 6, 2008, at Adams Memorial Hospital of injuries following a motorcycle /SUV accident in southern Adams County.

Cary A. Aspy: Man dies in accident (10/08/2008)

A rural Geneva man was involved in an accident in southern Adams County Monday that killed a Decatur man.

Cary A. Aspy, 48, 348 Mercer Ave., Decatur, was pronounced dead Monday at 5:35 p.m. at Adams Memorial Hospital. Adams County Coroner Leslie Cook ruled the cause of death as multiple blunt force trauma.

Aspy was taken to the hospital after his motorcycle and a sport utility vehicle driven by Tracy Toland, 45, 8393 South 300 West, Geneva, collided on county road 300 West.

Toland told Adams County police he was driving south on county road 300 West, and was attempting to turn east onto county road 850 South. Toland said a northbound truck appeared to be losing its load and looked in his rearview mirror to check. He then began to turn, not noticing the northbound motorcycle driven by Aspy. The 1995 Jeep Cherokee and the 2002 Kawasaki motorcycle then collided head on. Aspy was thrown from the motorcycle

Toland was cited by police for not yielding the right of way when turning left, driving without financial responsibility and for driving left of center while turning. Toland was not injured in the accident.

The 5:01 p.m. accident caused combined damage estimated at \$5,000 to \$10,000. The accident remains under investigation by Adams County police and the Adams County Coroner's office.

Berne and Geneva police assisted at the scene.
