Scott McDaniel Rites To Be Held Fri. P.M.

Well Known Jefferson Tp Farmer, Retired, Expires at Monroe, Tuesday

Scott McDaniel, aged and respected citizen of Jefferson township, lately living with his son Roy at Monroe, passed away last Tuesday morning at 8:30 o'clock. He had been in failing health for nearly two years, suffering from diabetes and an infected foot. Amputation of a leg became necessary a few months ago, however, this failed to add to the restoration of his health.

Mr. McDaniel was a life-long citizen and pioneer of this county. He was born in Mercer county, o., on January 20, 1861, thus reaching the age of 78 years, 2 months and 8 days. He was the son of William and Mary Foreman McDaniel. His marriage to Minerva McDaniel took place about 55 years ago in Wabash township. The wife preceded about two years ago.

Surviving are two sons, Roy of Monroe and Dick of Oakland, Cal. One brother James resides in California.

Preceding were his parents, his wife and two daughters and a son. One daughter, June, died last April.

Funeral services will be held at the L.L. ager home here Friday afternoon at 2:00 o'clock, at which place the body may be viewed until the time of the funeral. Rev. W. F. Johnson will officiate. Burial will be in the Crawford cemetery.

## Local Woman's Brother Dies

S.B Journey, 66, Brother of Mrs. Elmer Ludy, Dies

Stephen B. Journey, age 66 died suddenly Saturday morning at 7:20 due to a cerebral hemorrhage. His death occurred at the home of a son, Alva Journey, five miles south of Ft. Recovery, whom he had been visiting for two weeks.

A retired farmer, he had made his home the past several years with a daughter, Mrs. Carl Ludy on W. Third St. at Portland. He was born near Brice, Noble twp., the son of Robert and Emily (Gillette) Journey.

In 1898 he was married to Iva Shane felt who preceded him in death in 1914. Surviving are two sons, Alva, at whose home he died, and Charles, north of Union City; two daughters, Janelle, wife of Carl Ludy, W. Third St., Portland, and Florence, wife of Arthur Wagner, Nappanee, Ind., and 27 grandchildren and one great-grandson. One brother, J.R. Journey, south of Portland, and three sisters, Della, wife of Elmer Ludy, of near Berne, Mrs. Susan Hutchens, Portland, and Phoebe, wife of Dick Shawver, Pike twp., also survive.

Preceding him in death were two daughters two grandchildren, three brothers and two sisters. Funeral services will be conducted Tuesday afternoon at 2:00 from the Antioch church with Rev. J.O. Lewis officiating. Burial will be made in the Antioch cemetery.
