Thence he moved to Ohio, and in 1820 settled in Vigo County, Indiana, where he has ever since resided. He was elected to the Legislature in 1827, and has always borne the character of a highly respectable and honest man. Mr Jackson has raised a large family, many of whom were settled around him. He was a valued member of the Methodist Episcopal Church for the last thirty years of his life. And now passes to the grave in a good old age - leaving behind him a reputation of great worth, and a character, that any or all may be proud to hold up as an example, for imitation before the world.
